INFORMATION & RULES

1. Entry fees & stall rentals for September 2, 2017 Estevan Horse show must be sent to **Estevan Exhibition c/o Linda Molyneaux, 510 -4th Street, Estevan, SK S4A 0V3 or Fax 634-0186 or Email: l.smith@bbaxtertransport.ca. Cellular 306-421-7838**
Entry Deadline is August 28, 2017
2. **All Exhibitors are required to pay Gate Admission upon arrival.**
3. Box Stalls are \$15.00/day. **Box Stalls are limited.** There are no Tack Stalls or Tie Stalls. **It is imperative that exhibitors send money to reserve stalls. A separate cheque for \$20/stall for stall cleanout is required. The cheque will be returned when stall is inspected.**
4. Exhibitors must notify Ring Steward of Tack Changes.
5. Exhibitors must fill out the entry form enclosed. In making entry, the owner assumes all liability on account of accidents to horse, pony, or property & releases Estevan Exhibition Association from any responsibility and will sign a waiver before competing. Waivers are included.
6. The name of the horse or pony and the name and age of the youth exhibitor as of January 1, 2017 must be given on entry form.
7. **Youth Exhibitors must send photocopy of their birth certificate for proof of age.**
All Youth 18 years of age and under Must Wear ASTM helmet.
8. The show committee reserves the right to split or cancel classes as entries warrant.
9. Where height is a factor, entries may be measured.
10. Each horse may be entered up to three times with a different rider to each horse/rider combination.
Separate entry forms required for each rider.
11. The judge may send any entry from the ring for bad behavior.
12. All classes requiring a pattern will have the appropriate pattern posted prior to class.
13. All horses withdrawn from classes must have the Exhibitor present a Vet certificate for a refund of fees.
14. No person, other than the judge, directors in charge, the ring steward, the clerk & the necessary attendance for each animal judged shall be allowed in the show ring.
15. Neither the Estevan Exhibition Association nor any of its officials shall be responsible for the loss or injury from whatsoever cause to exhibitor, person, or property, although care will be taken to prevent such loss or injury, neither are they responsible for typographical errors that appear in the prize list.
16. The management reserves the right to remove from the grounds any exhibitor and animal that may be falsely entered or may be deemed unsuitable, objectionable, without assigning any reason therefore; & management shall be exonerated from any claim whatsoever, on the part of the exhibitor or purchaser, for any such removal.
17. An exhibitor making an entry, by doing so agrees to the rules and regulations printed herein; or afterwards to be made by the Directors for the government of the Exhibition.
18. All protests shall be made in writing and accompanied by a deposit of \$20. In the event the protest not being sustained, the deposit will be forfeited to the Exhibition. Protests should plainly state the cause of the complaint or appeal and must be handed to the Horse Show Secretary on the day issued & not later than 4 p.m. on the last day of the Exhibition. No statement based on the assertion that the judge is incompetent will be considered by the directors. Protest shall be decided by a majority vote of the directors present at a meeting when such protests are considered.

19. Any person who shall attempt to interfere with a judge while discharging his/her duties, or refuses to accept a judge's award, or at any time while on premises of the Exhibition use contemptuous or abusive language to a judge, SHALL BE EJECTED, & if an exhibitor, he shall forfeit the right to any premium to which he might be otherwise entitled & may be excluded from the exhibiting for one year thereafter. The judges are particularly requested to report any misconduct that comes to their attention.
20. Exhibitors shall submit to the requirements of the Judge, otherwise their entries will be disqualified.
21. Attempts to artificially cover defects in livestock exhibits will be disqualified & owner (at discretion of the committee) may forfeit any other livestock awards he/she has won.
